

TACWA Meeting Minutes San Antonio, Texas September 23, 2022 9:00 a.m.

The Texas Association of Clean Water Agencies (TACWA) meeting on September 23, 2022, was hosted by San Antonio Water System (SAWS) and sponsored by San Antonio Water System, Freese and Nichols, Plummer, Garver, CP&Y an STV Company, and Burns McDonnell.

Business Meeting:

- President Bill Gase opened the business meeting, welcomed guests, and thanked SAWS for hosting and the sponsors for their contributions.

Regionalization

- TCEQ recently issued a guidance document on regionalization, providing a bit more concrete information in addition to what TWC 26 details. It identifies three factors to consider, if you have a new or proposed plant:
 - Is there a system within three miles of proposed site?
 - Was service requested from that nearby facility and was permission granted (or denied)?
 - Can you be granted an exception or is it cost prohibitive to tie into the neighboring facility?
- A stakeholder public comment meeting was held regarding regionalization at TCEQ recently. A discussion on whether current regionalization guidance still applies and whether the additional three factors (noted above) should still be taken into consideration. Currently posted on the TCEQ website with comments due October 23rd.

CERCLA

 EPA has talked about designating PFAS compounds, specifically PFOA and PFOS as CERCLA hazardous substances. On September 6, the proposed rulemaking was added to the Federal Register with a 60-day public comment period that ends November 7th.



 National organizations, NACWA, AWWA, WEF and others have submitted a letter requesting an additional 120-day comment period, due to the extensive and impactful nature of this. In addition, the letter points to the need for an economic analysis/justification.

WEAT Nutrient Committee

O A summary letter of information gathered over the past approximate 18 months was recently sent to committee members. Looking at how the TCEQ will implement this in permits and how this group can impact that. On November 3 in Austin at the Center for Environmental Research Auditorium at Hornsby Bend, an Eckenfelder Lecture will wrap up findings and decisions made on what to present to TCEQ. TDS Coalition

 TDS Coalition met with TCEQ to discuss Implementation Procedures for TDS. It was a high-level meeting with great discussions and input. A letter was issued to the TDS Coalition members; it provides an overview of the discussion and relates some of the TCEQ questions/responses.

- Elections start on November 8th. The following Tuesday is always the first day of pre-filing for the next legislative session; the 88th legislative session pre-filing start date is Nov 14th. The first date of legislative session is January 10, 2023.
- The interim period between the two legislative sessions held two late hearings in August 2022 from the Natural Resources Committee. Their interim report is due late October, early November. It should provide a hint at what to expect during the legislative session and a look at what the committee's focus may be. The expectation is Tracy King will be Chairman again.
- Water caucus may occur this session due to drought and continual low rainfall in Texas.
 Preliminary workings began last spring with several organizations (WEAT, TWCA, Texas Rural, etc.) pushing to get water quality and supply issues into sharper focus. This caucus will allow for a larger platform and audience to bring forth discussion topics.
- Proposed legislation submitted by WEAT is in legislative council right now that is intended to shorten discharge permit turnaround time by allowing online TPDES notifications, in lieu of newspaper notifications. This brings Texas in line with federal regulations.
- Note that CERCLA proposed rulemaking in the federal register has a reporting threshold of one or more pounds of PFAS generated every 24 hours in your discharge or residual. Rudimentary NACWA studies show that some will not meet this threshold. TCEQ guidance on testing and measurement not here yet.
- HORIZON Conference is November 15th in Austin from 9 am to 4 pm, one day after the prefiling kick-off. We will have elected officials. Among the speakers are Andrew Sawyers,
 Director of the Office of Wastewater Management at EPA HQ, Yvonne Forrest, Deputy
 Director of Houston Water for City of Houston, and Jenna Covington, Executive Director and
 General Manager of the NTMWD. Early registration ends October 28 at the following link:
